Additional Information on PRM service

October 2018



- As already illustrated in the documentation published on 9 August, the 2019 charge proposal for the PRM service at FCO is € 0.99 / pax. The increase to the current rate is due to the growth in the number of assistances provided at FCO, which has led to obvious consequences on the costs that are not entirely rewarded through the increase in passengers paying for the service. The 2019 tariff proposal is also affected by the deficit (costs > revenues) that is reasonably foreseeable in the current year.
- ADR's purpose is to introduce a new methodology for determining the charge for PRM service at FCO. The mechanism is going to be applied starting from the 2020 tariff proposal and is similar to those applied in other main European airports (ADP, Gatwick, others). It provides for differentiation of the fee applied for the PRM service with the explicit aim to reward carriers with the highest number/ratio of assistance booked in advance, but at the same time guarantees the airport managing body to fully recover the costs of service provided.
- A historical analysis of the bookings within a certain "efficiency" threshold (defined at 24-36 hours before the flight time) indicates FCO there many companies that proficient that at are are not in bookina the service enough in advance, with significant consequences in terms of costs for ADR Assistance
- The foreseen mechanism that ADR aims to introduce in 2020 guarantees transparency on the cost correlation of tariffs and will be articulated as follows:
 - Charges distribution into low / mid / high clusters on the basis of the historical percentage of assistances booked
 - 2019 performances on % of bookings registered by carriers will rank them within one of the "clusters" for charges differentiation
 - In the case of a deficit / surplus deriving from the difference between expected and effective volumes, the gap will be included within the allowed costs in the subsequent year.

- At the end of 2017 FCO registered a surplus of 99 € thousand (ADR SpA revenues of 17,396 € thousand vs. 17,298 € thousand of eligible costs)
- The 2018 forecast assumes a deficit of 968 € thousand (ADR SpA revenues 17,914 € thousand vs. eligible costs 18,883 € thousand)
- 2019 provides for a breakeven between expected costs (including expected deficit recovery 2018) and revenues, by applying an equilibrium charge equal to€ 0,99 from 1 March 2019

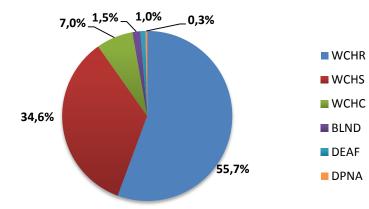

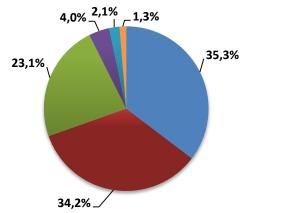

WCHR

Passenger who can walk autonomously inside the aircraft and go down and up the stairs, but who needs a wheelchair or another means of transport to move inside the terminal.

WCHS

Passenger who can walk autonomously inside the aircraft and go down and up the stairs, who can not go down or up the stairs and who needs a wheelchair or other means of transport to move inside the airport.

WCHC

Immobilized passenger, who needs a wheelchair to move and needs assistance from the time of arrival at the airport until the end of the flight as well as to exit the airport.

BLIND

Passenger with optical impairment.

DEAF

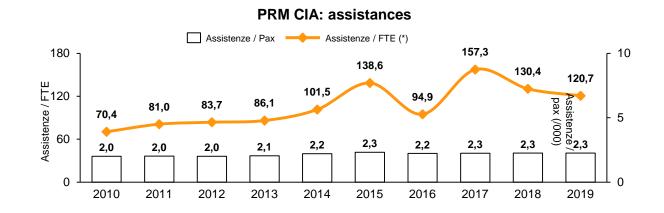
Passenger with hearing impaired or impairment of speech.

DPNA

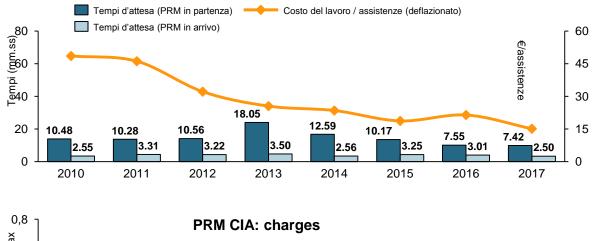
Passenger with intellectual disability needing assistance.

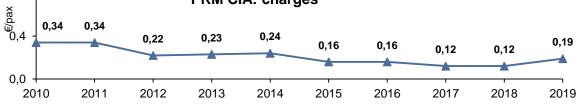
PRM CIA: 2010-2019

SERVICE MANAGEMENT

- ADR has entrusted the PRM service to a 100% owned subsidiary, ADR Assistance S.r.l., established in 2008
- The costs allowed for the determination of the charges are directly recorded in the income statement of the subsidiary, in balance with the financial statements
- The surplus / deficit recorded is shown by comparing the costs related to each of the airports managed with the revenues that the airport manager accounts to the airlines on the basis of their effective boarded passengers, excluding CMGs, CRBs and exempt newborns
- In line with the provisions of the ENAC-ADR Agreement, the new PRM charge enters into force on 1 March of the subsequent year.

FACILITIES AND INFRASTRUCTURES

Main infrastructures and equipment used to carry out the PRM assistance service:

- UFIS-GRAMS information system for dispatching and traceability of the service
- Workstations for the reception of PRM in the terminals and in the boarding areas (8 to FCO and 1 to CIA)
- Wheelchairs for the transport of Pax PAX
- N ° 38 Minivan vehicles (of which 37 FCO and 1 CIA)
- N ° 18 Ambulift vehicles (of which 16 FCO and 2 CIA)

STAFF AND COSTS

- Workforce at 12/31/2017: 300 UNITA (of which 294 A FCO and 6 A CIA)
- Equivalent full-time: 303.8 (of which 297.5 FCO and 6.3 CIA)

Staff costs: labor cost Budget 2017 = € 13.379 / thousand. 2017 staff costs from the 2017 regulatory accounting: € 14,069 thousand of which € 13,778 thousand of FCO and € 291 thousand of CIA (see slide 7)
