

## **Terms and Conditions of the “FURLA FLY OUTSIDE EUROPE” gift programme (“Terms and Conditions”)**

### **ARTICLE 1 - SPONSOR**

Furla S.p.A., VAT no. IT00610091209, with registered office at Via Bellaria 3/5 40068, San Lazzaro di Savena (BO), Italy (the “Sponsor”).

### **ARTICLE 2 – TYPE OF PROGRAMME**

Free gift with purchase

### **ARTICLE 3 – NAME OF THE PROGRAMME**

Furla Fly Outside Europe (the “Programme”).

### **ARTICLE 4 – PROGRAMME PERIOD**

From 12<sup>th</sup> October to 30<sup>th</sup> November 2017 (the “Programme Period”).

### **ARTICLE 5 – GEOGRAPHICAL SCOPE OF THE PROGRAMME**

### **ARTICLE 6 – ELIGIBLE PARTICIPANTS IN THE PROGRAMME**

All individuals holding a flight ticket departing from Fiumicino Airport with a destination in a country EXTRA SCHENGEN - NON UE, when they make a purchase of one or more of the Sponsor’s products at the Programme Store during the Programme Period.

### **ARTICLE 7- HOW THE PROGRAMME WILL BE CONDUCTED**

During the entire Programme Period, when making a purchase at the Programme Store of one or more of the Sponsor’s products, regardless of their nature and number (the “Purchase”), all individuals holding a flight ticket departing from Fiumicino Airport with a destination in a country EXTRA SCHENGEN - NON UE will receive a free Gift (one unit for each Purchase), as defined in these Terms and Conditions.

By purchasing the Sponsor’s products at stores other than the Programme Store will not entitle the purchaser to receive any Gift in relation to those purchases.

A single Purchase transaction (identified by the issuance of a single receipt) entitles the purchaser to receive a single Gift.

The Gift will be delivered when the Purchase is made.

Gifts will be available until stocks run out.

Gifts may not be substituted for other products or converted to cash.

In the event of substitution of the product(s) purchased that entitled the purchaser to receive a Gift, the delivery of the new product(s) will not entitle the purchaser to receive an additional Gift.

If the Gifts are no longer available, the Sponsor may substitute articles of similar, equal or greater value for the Gifts by giving advance notice as provided in these Terms and Conditions.

The right to receive a Gift is subject to verification by the Sponsor's staff at Programme Stores that Programme participants have met the requirements of these Terms and Conditions.

#### **ARTICLE 8 – GIFT**

Subject to the terms of the Article above, the gift consists of a “*Venus*” *keychain heart or bow* with an indicative value of € 50, including VAT (the “Gift”).

#### **ARTICLE 9 – PUBLICITY**

These Terms and Conditions will be available directly in the Programme Store, on the Airports of Rome web-site and through link from the splash page to the airport wi-fi connection.

- For any complaints and/or requests for clarification, the participants of the Programme must contact exclusively Furla Spa as the sole responsible and holder of the Free gift with purchase operation, and not Airports of Rome.
- The Sponsor reserves the right to change the provisions of the articles of these Terms and Conditions at any time in whole or in part, as long as it does not impair the rights of the individuals eligible to participate in the Programme. The Sponsor agrees to inform such individuals of any such changes in accordance with the notice provisions stated in these Terms and Conditions or in an equivalent manner.
- The Sponsor may change, suspend or cancel this Programme at any time due to force majeure which makes it impossible to continue the Programme. In that event, it will inform individuals eligible to participate in the Programme in accordance with the notice provisions stated in these Terms and Conditions or in an equivalent manner.
